ENDOWED SCHOLARSHIPS (BY COLLEGE) A named endowed scholarship requires a minimum investment of \$10,000. The earned interest is used to provide scholarships. Therefore, the gift continues in perpetuity to provide assistance to worthy students. The amount that may be awarded from each endowment is established through a spending policy adopted by the UL Lafayette Foundation Board of Trustees. In setting the spending policy, the trustees consult with the university to determine current funding needs, and then balance those needs against the need for long-term growth of principal. For without scholarship growth, scholarship endowments will lose their "purchasing power" over time. Currently, spending from endowments is set at approximately five percent of the current cash principal amount in the endowment. Additional earnings are added to the principal of each fund.
